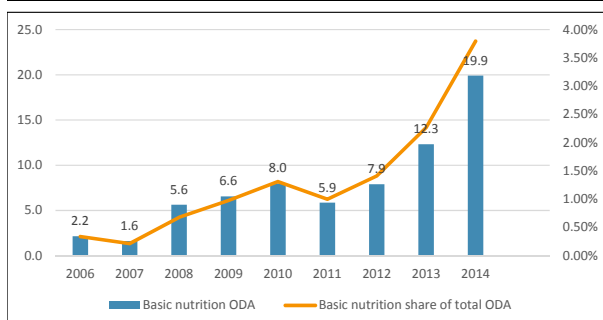


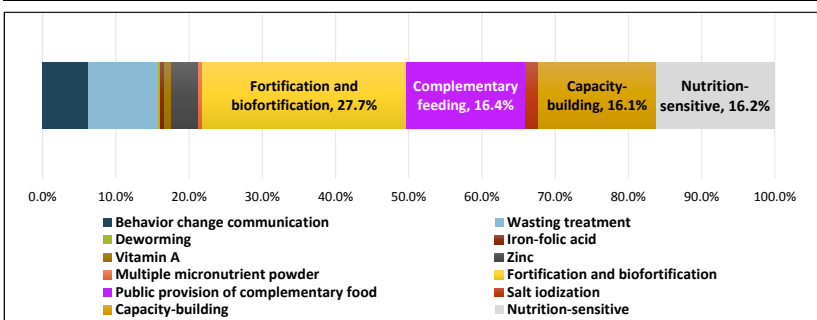

## Intervention segmentation of basic nutrition code (12240)<sup>d</sup>

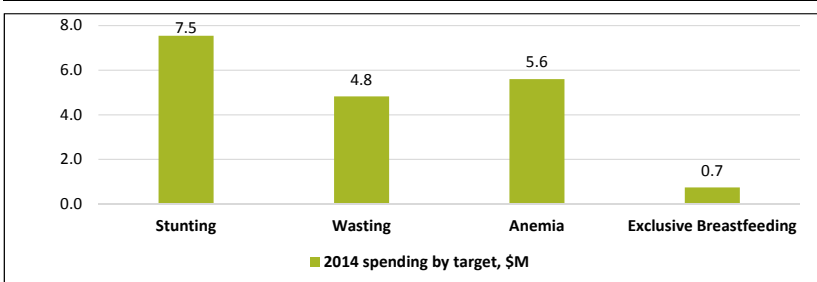

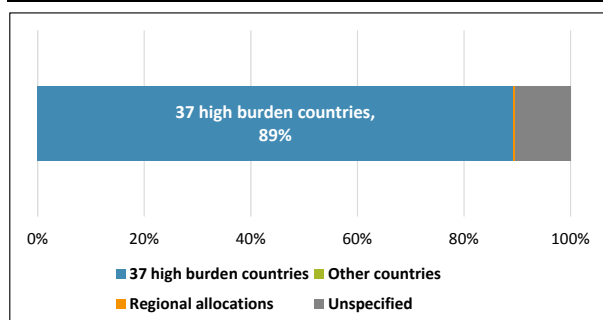
