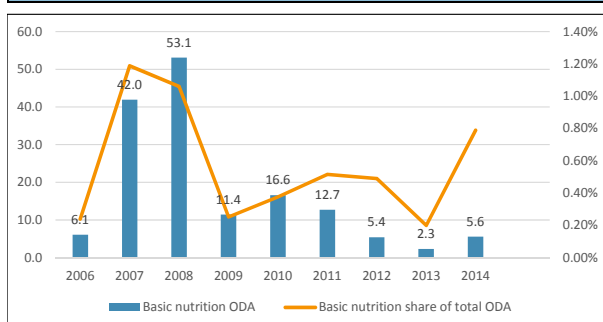


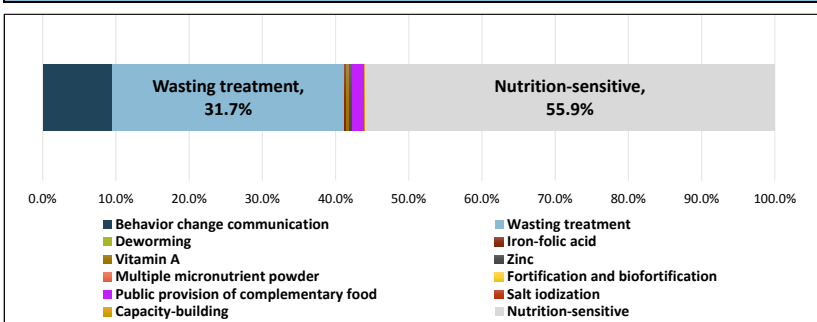

Intervention segmentation of basic nutrition code (12240)^d

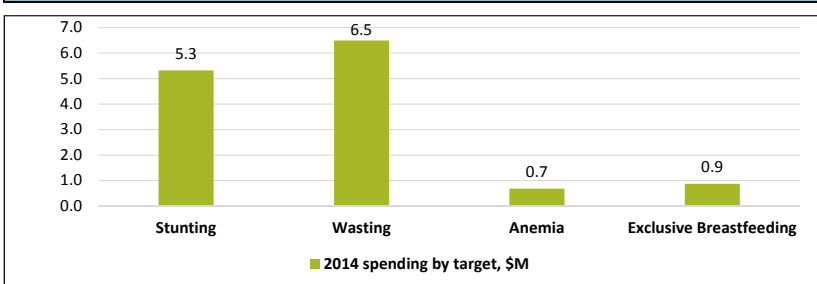


Share of basic nutrition funding going to Priority Package interventions (as defined by the Global Investment Framework): 42%

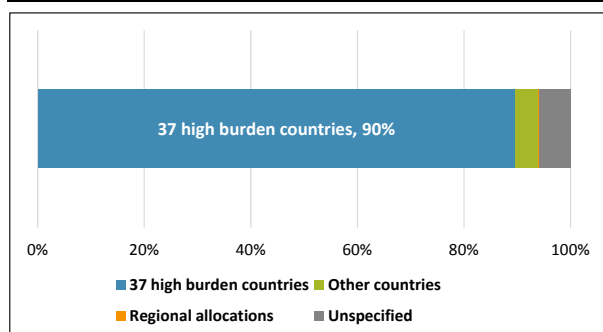
